



Introducer Agreement

1. Parties

This Introducer Agreement is made on

- MS Lending Group Limited (the "Lender"), incorporated in England and Wales under company number (CRN 12723324) with registered office at 1st Floor Cloister House, Riverside, New Bailey Street, Manchester, England, M3 5FS.
- MS Lending SPV1 Limited (the "Lender"), incorporated in England and Wales under company number (14258810), with registered office at 1st Floor Cloister House, Riverside Building, New Bailey Street, Salford, England, M3 5FS.
- MS Lending SPV 3 Limited (the "Lender"), incorporated in England and Wales under company number (14258853) with registered office at 1st Floor Cloister House, Riverside Building, New Bailey Street, Salford, England, M3 5FS.

2. Duration

This agreement starts on the date when the Introducer first places business with the Lender and remains in force until terminated in accordance with this agreement.

3. Background

The Introducer has contacts who may be interested in short-term finance provided by the Lender.

The Lender agrees to pay a commission on completed deals introduced by the Introducer, as set out in this agreement.

4. Introduction

4.1 The Introducer may (but is not obligated to) introduce potential borrowers to the Lender, and agrees to:

- Conduct introductions in a professional and courteous manner;
- Ensure any information provided is accurate and not misleading;
- Obtain any consents required from applicants for the Lender to process their information.

4.2 The Lender is not obligated to offer a loan to any applicant introduced.

4.3 The Introducer is not an agent of the Lender and must not make representations, agreements, or commitments on behalf of the Lender.

4.4 Business is submitted by way of a paper application process.

5. Applications

5.1 Before submitting an application the Introducer shall ensure the information provided by the applicant is accurate, complete, and not misleading.

5.2 The Introducer must not make statements inconsistent with the Lender's offering and should present the Lender's products clearly.

5.3 The Lender may decline any application at its sole discretion.

6. Data Protection

The Introducer must ensure that applicants' personal information is handled lawfully and appropriately, and that applicants have given permission for their information to be shared with the Lender.

Both parties agree to maintain appropriate safeguards to protect personal data in accordance with applicable data protection laws.

7. Fees

7.1 A commission will be paid upon successful completion (drawdown) of a loan introduced by the Introducer, at rates and terms agreed between both parties in writing.

7.2 Any overpayments or payments made in error must be repaid to the Lender on request.

8. Termination

The Lender may terminate this agreement with immediate effect by giving notice to the Introducer.

Termination does not affect the Introducer's entitlement to commission for loans completed prior to termination.

9. Limitation of Liability

9.1 Nothing in this agreement limits or excludes liability for fraud or fraudulent misrepresentation.

9.2 Subject to 9.1, the Lender shall not be liable for indirect or consequential losses.

9.3 The Lender's total liability to the Introducer shall not exceed £0 per claim and £0 in aggregate.

10. Collaboration

Both parties agree to act in a cooperative manner and communicate openly to support the introducer relationship.

11. Indemnity

The Introducer agrees to indemnify the Lender against any costs, losses, or claims arising from the Introducer's breach of this agreement.

12. Confidentiality

Both parties will keep confidential all information obtained during this agreement.

13. No Partnership

Nothing in this agreement creates a partnership or agency relationship between the parties.

14. Entire Agreement

This document represents the entire agreement between the parties and replaces any prior agreements or understandings.

15. Severance

If any part of this agreement is found to be invalid, it will not affect the rest of the agreement.

16. Complaints

The Lender will deal with complaints in line with its internal complaints process.

The Introducer will notify the Lender of any complaints relating to the Lender's activities and will provide reasonable cooperation.

17. Fraud and Financial Crime Prevention

The Introducer will conduct reasonable checks on applicants to confirm their identity and legitimacy. Solicitors acting in the transaction will support anti-money laundering procedures where applicable. Both parties agree to maintain procedures to prevent financial crime.

18. Intellectual Property

If the Introducer wishes to use the Lender’s logo or branding, they should contact the Lender for permission.

19. Law and Jurisdiction

This agreement is governed by the laws of England and Wales and Scotland.

The parties agree that the courts of England and Wales or Scotland (as applicable) shall have jurisdiction.

20. This agreement was entered into on the date stated above.

21. Declaration

MS Lending Group uses and retains details you give about yourself, to manage your registration and Broker relationship with us, for research or analysis and to prevent fraud. These details will be shared with others including credit and fraud prevention agencies for these purposes.
